Dear Applicant:

Welcome to the Village of North Haven Waterways. If you wish to re-new your application for the upcoming Season, please fill out the attached application with the details of your vessel so our records are up to date. The completed application is to be sent to the Village Office along with your payment. Please note that mooring fees are non-refundable, and a surcharge will apply to vessels left in the mooring field beyond October 31<sup>st</sup>.

Moorings are issued on the first come basis. Residents have first priority and all bills must be paid by March 31<sup>st</sup>. Currently there is a waiting list and moorings are non transferable.

- The Village will also require, as part of your application, proof of mooring inspection including the last date of inspection of all ground tackle by your private contractor.
- Please include a copy of a valid registration or other current documentation.
- Also include a copy of your current Insurance Policy.

PLEASE NOTE THE FOLLOWING INFORMATION:

These Waterways are a STATE REGULATED NO DISCHARGE HARBOR ZONE. A pump out service is provided by the Town of Southampton and can be reached on VHF 78. All vessels are subject to compliance inspections by the Harbor Master, State and local law enforcement officers.

All vessels are to be secured in a seamanlike fashion with the appropriate lines and chafing gear. Owners assume all responsibility for the safe keeping of their vessel and are responsible for any damage caused by said vessel. If necessary, designate a responsible entity in your absence.
