NORTH HAVEN VILLAGE TENNIS COURT RULES AND REGULATIONS

USE OF THE COURT IS LIMITED TO NORTH HAVEN RESIDENTS OR TENANT (ATTACH LEASE) AND THEIR GUESTS UPON PAYMENT OF \$50.00 PER YEAR PER FAMILY.

MAKE APPLICATION TO THE VILLAGE CLERK

COURT MAY BE RESERVED NO MORE THAN ONE (1) DAY IN ADVANCE. RESERVATIONS MAY BE MADE AS EARLY AS 7:00 A.M. ONE DAY IN ADVANCE. EARLIER SIGN-INS WILL BE REMOVED.

ONLY ONE TIME SLOT PERMITTED ON ANY GIVEN DAY.

SINGLES ARE ALLOWED ONE (1) HOUR OF PLAY, DOUBLES ONE AND ONE-HALF (1 ½) HOURS.

SIGN IN ON THE SCHEDULE BOARD OUTSIDE THE VILLAGE HALL BUILDING IN THE KIOSK. PLEASE SIGN YOUR NAME AND PERMIT NUMBER. YOU MUST CARRY OR HAVE AVAILABLE YOUR PERMIT CARD WHILE USING THE COURT.

AT THE END OF PLAY PLEASE ERASE YOUR NAME FROM THE SCHEDULE BOARD.

IF YOU ARE GOING TO CANCEL PLEASE ERASE YOUR NAME AS A COURTESY TO MAKE THE TIME AVAILABLE FOR OTHERS TO SIGN IN. FAILURE TO USE THE TIME SLOT WITHOUT CANCELLING IS SUBJECT TO LOSS OF TENNIS PRIVILEGES.

IF PLAYERS DO NOT ARRIVE WITHIN 10 MINUTES OF THEIR SCHEDULED TIME, THE COURT WILL BECOME AVAILABLE ON A FIRST COME, FIRST SERVE BASIS.

GUESTS MUST BE ACCOMPANIED BY A MEMBER.

CHILDREN CANNOT PLAY ON WEEKENDS UNLESS ACCOMPANIED BY AN ADULT.

YOUNG CHILDREN (UNDER AGE 12) MUST BE SUPERVISED.

NO PETS ON THE COURT

TENNIS SHOES ONLY ON COURT SURFACE. BLACK SOLED SHOES ARE PROHIBITED

RELEASE THE TENSION ON THE NET WHEN YOU LEAVE AND LOCK THE COURT.

PLEASE KEEP THE COURT CLEAN. BE CONSIDERATE OF THE NEXT PLAYER.
